## PROMOTER LICENCE

of International Kickboxing Council, represented by the president, issue for professional martial arts, sports combat and Kickboxing in all styles for the promoter

§ 1 Each event / gala / show must be announced by e-mail or fax 30 days before and official approved by the International Kickboxing Council office and the official IKC matchmaker. The use of IKC Logo on poster and documents without approval is forbidden and illegal and will be prosecuted by law.

This announcement must contain:

- a date, begin and venue of the event
- b date, time and venue of the weigh-in and official medical check-up, min. two hours before the first fight c kind of event e.g. national, international, by title fight with name of fighters, record and last three fights d name of the local licensed matchmaker for that event
- e name of the official attending ring doctor / physician

§2 any results of that mentioned event must be announced within eight days by mail or fax to the International Kickboxing Council head office to be confirmed and for the official ranking list.

- § 3 PR , TV and any media work must be done in a serious way, particularly by title fights.
- §4 During weigh-in the sportbook / sportpass from each fighter must be checked for correct identity of the fighter, annual valid medical check and for possible doctors order - a suspend because of a knock out. If the doctor block a fighter for medical reasons on the day of the event is there no fight on that day. No protest against doctor's / medic's decision is allowed.
- §5 For national and international events without a title fight the obligation of referee and judge is in Supervisors own discretion.
- For title fights IKC head office must be informed before the events, which referee / countries are involved. **International Kickboxing Council decides the right any time for objection and to stipulate 5 men / women neutral referee team.**
- International Kickboxing Council reserve in a way the right, to send an official IKC **Supervisor**. The cost of such supervisor has been taken over by the promoter and will include travel, proper hotel and food. The supervisor has the right to observe the weigh-in, to see any official documents and score sheets at any time. After consulting the head referee of the event he can cancel the title fight for legal reasons or to declare the fight as „no contest“ after 24 hours.
- § 6 The match must be done in a proper way, according our IKC rulebook, make sure for the fighting record of both fighters, to avoid a mismatch or a obviously overqualified fighter facing a newcomer. Newcomer (N/C class) and good experienced amateurs (B class) can not fight professional fighters. Only A-class fighter can fight against other A-class fighter. If a B-class fighter just sign a contract for an A-class fight is no more amateur fighter B-class.
- § 7 All fees for international title fights has to be transferred not later than 30 days before the event to IKC PAYPALorWU (Only on request) account. If the fee is not on the account the approval is expired. All fees and outstanding amounts must be paid in Euro, except of charges. Please ask in the office for actual fee, account number above.
- §8 This licence is valid 12 month, beginning with the day of payment. In cause of violation of one or more paragraphs, this licence can be declared as invalid.
- §9 Purses of all fighters must be prepared before the first fight starts. Official has to wear a tie, and all referees official dress code like black polo shirt with big IKC logo on the back and small in front heart side, and – if they wish so - be paid before the event start.
- §10 Weigh-in for title fights must to be done compulsory just on calibrated scales, both coaches and fighters must be present. The official ring doctor / medic must be present and check-up all fighters. The ring must have four ropes, AIBA norm is compulsory. This licence must be prepared in copy during the event. With my signature I accept all paragraphs and conditions.
